The term "lessee" refers to the principle responsible renter of 1210 North Shore Dr. during the duration of this agreement.

The term "lessor" refers to the owner of the LSV Plate#

The term "golf cart" and "LSV refers to a Street Legal Golf Cart NC License Plate#_____

- 1. ____The Lessee agrees that only drivers with a valid driver's license and 21 years or older will operate the golf cart.
- 2. ____The Lessee agrees to operate the golf cart according to all NC State and Town of Sunset Beach Laws and regulations that govern the use of Low-Speed Vehicles (LSVs) on town and state roads such as but not limited to speed and parking.
- 3. ____The Lessee agrees that the golf cart will only be used on Sunset Beach Island and that it *will never* be used to cross the bridge to the mainland or operate on the Causeway leading to the bridge.
- 4. ____The Lessee assumes all liability for any injury, death and property damage resulting directly or indirectly from the operation, use, or possession of the LSV always before the LSV is returned to the lessor and agrees to hold the Lessor and Sunset Properties Inc. harmless from any claim arising there from.
- 5. _____The Lessee assumes all risk of vehicle damage, loss, or theft, partial or complete from any cause. The Lessee will pay the cost of all repairs and/or replacement parts. If the LSV is lost, stolen or destroyed the Lessee will notify the Lessor/Sunset Properties immediately.
- 6. _____The Lessee acknowledges that the operation of an LSV in traffic and in the proximity of other vehicles is inherently dangerous. The Lessee expressly assumes the risk of death and injury resulting from the operation of the LSV and releases the Lessor and Sunset Properties Inc. from any future claims for compensation of any kind of amount brought by the Lessee or his/her heirs, successors, representatives or assigns.
- 7. ____No refund. If the LSV fails to operate properly. The Lessee will notify the Lessor and Sunset Properties Inc. who agree to have the vehicle serviced *ASAP* and brought back to operable condition as soon as it can be. Lessee acknowledges that it may not be able to be repaired during their stay. No refund will be issued based on failure of the LSV.

- 8. ____Insurance: The Lessee understands and acknowledges that NC State Law does require the operator or the LSV to have insurance which covers all drivers. The Street Legal golf cart does have liability insurance coverage on it for the Lessor. The Lessee further acknowledges that there is no insurance coverage provided by the Lessor or Sunset Properties to cover the Lessee, or any other person riding in the LSV covered by this agreement. The Lessee further agrees to hold the Lessor and it's agents, harmless for any damage or injuries which Lessee may sustain incident to the operation of the Lessors LSV.
- <u>Indemnification: Lessee agrees to indemnify and save the Lessor and Sunset</u> Properties Inc. harmless against all claims and liability of any kind or nature not otherwise covered herein and all costs and expenses including reasonable attorney fees incurred in connection therewith related to or arising from the possession use and maintenance, condition, or operation of the LSV.
- 10. ____The Lessee agrees to allow the Lessor to pay for whatever repair costs are needed from the security deposit/damage waiver/insurance to repair any damages. Should the repairs not be determinable at the time of the inspection the Lessee agrees to allow the Lessor to establish repair costs within one week following the end of the rental period. The Lessee further agrees that if the repair costs exceed the amount of the deposit/damage waiver that the Lessee will pay for the additional charges.

- 2. <u>Waiver and Release and Indemnification:</u> I and on behalf of my child agree to forever release and discharge Greg and Karen Siders as well as Sunset Properties Inc. from all liability and agree not to sue either party if I or my child sustain any property damage and loss, personal injury, emotional distress, illness, disability, or death related to our use of the kayaks.
